

1. Registration details:

- For faculty: Rs. 2500 and Rs. 4000 for 40 and 80 hours FDPs respectively.
- For Industry participants: Rs. 7500 and Rs. 12000 for 40 and 80 hours FDPs respectively.
- For Research scholars : Rs. 2500 and Rs. 4000 for 40 and 80 hours respectively
- Research scholars are allowed for each FDP up to maximum of 5% of the strength.
- Faculty of SC/ ST Category: Rs 1250 and Rs 2000 for 40 and 80 hours FDPs respectively from July 1<sup>st</sup> 2017 – June 30<sup>th</sup> 2018 as per GOI Norms. (ie; up to a maximum of 22.5% of total strength)
- Faculty of SC/ ST Category: Rs 1875 and Rs 3000 for 40 and 80 hours FDPs respectively from July 1<sup>st</sup> 2018 June 30<sup>th</sup> 2019 as per GOI Norms. (ie; up to a maximum of 22.5% of total strength)
- SC/ST concession is only for faculty on first-come-first-give-concession up to a maximum of 22.5% of total strength on production of caste certificate. Research Scholars are not eligible for SC/ST concession.
- Complimentary registrations can be given at the ratio of 1:5. i.e., One free registration for every 5 registrations of host institution faculty given the condition that if the total number of participants of the FDP is 50 or above 50.
- 2. Registration kit will be provided by the academy only.
- 3. Accommodation and food charges for participants should be provided by Host institute only.

4. All travel, lodging and boarding expenses for all speakers will be met by academy. Host institute should arrange accommodation for speakers and pick up as per their travel plan. Academy coordinator will reimburse the expenditure incurred for this purpose through wire transfer after completion of the programme.

5. Coordinator's honorarium is shared to both coordinators equally.

6. Spot registrations with cash payment may be considered only as a special case.
