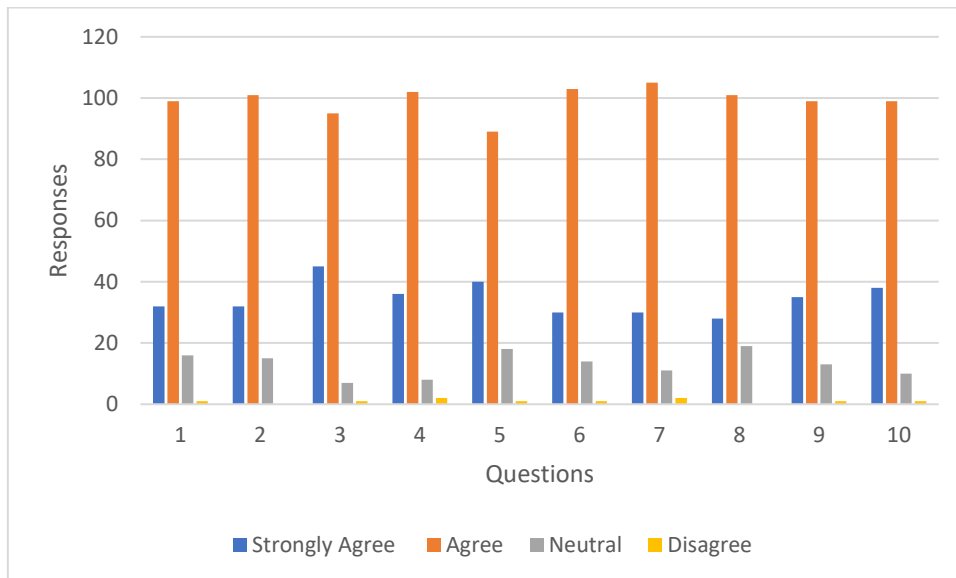

Graph Representation for Students' Feedback Response

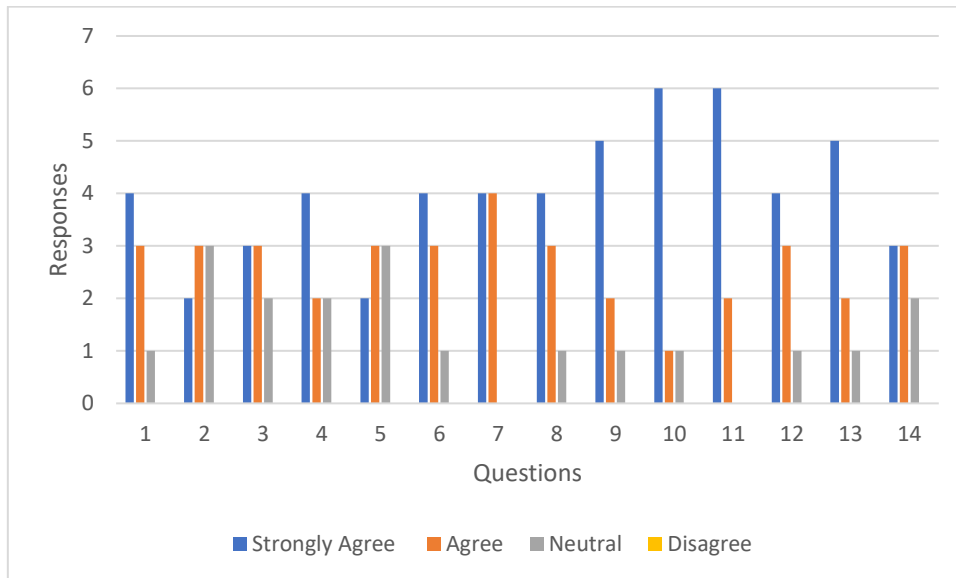

Graph Representation for Faculty Feedback Response

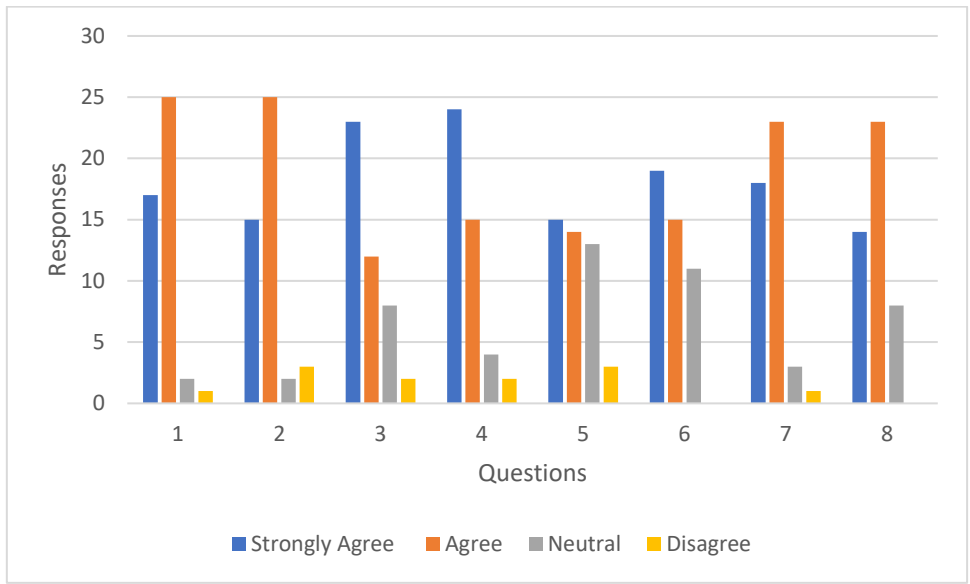

Graph Representation for Alumni Feedback Response

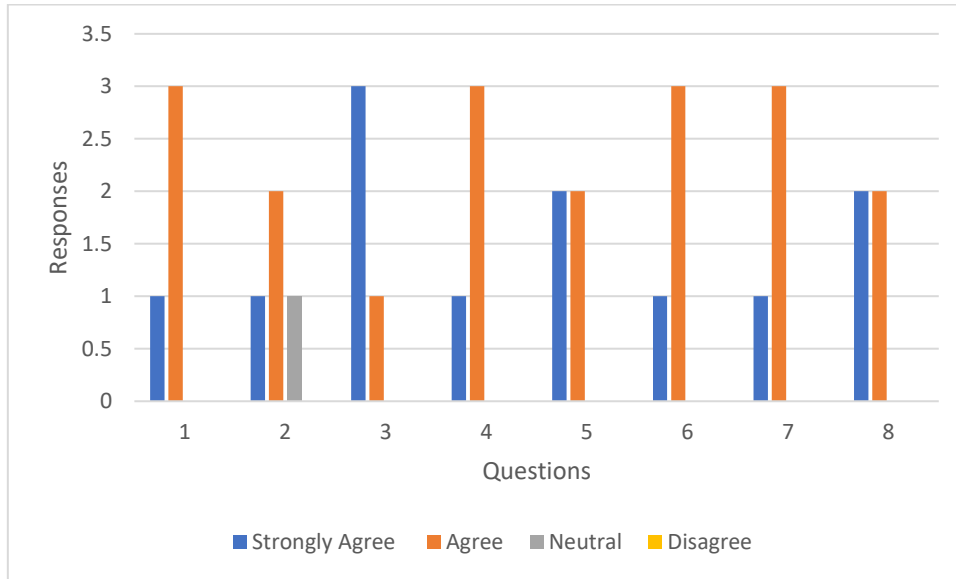
