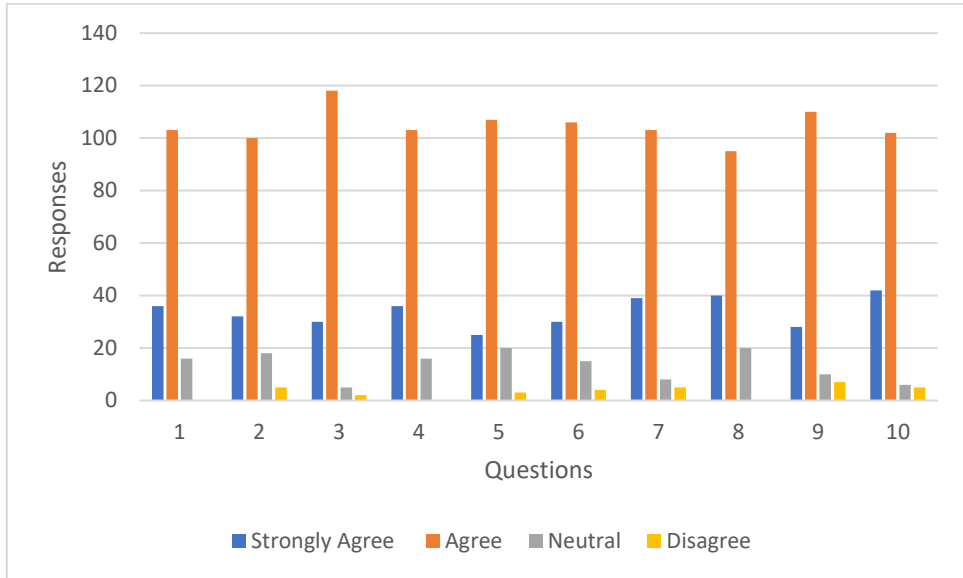

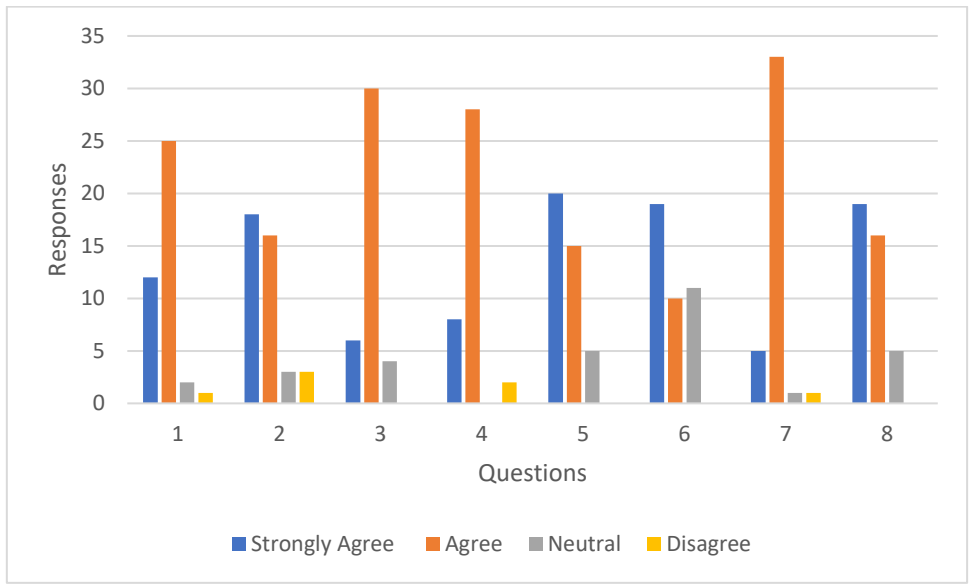
**Graph Representation for Students' Feedback Response**

**Graph Representation for Alumni Feedback Response**

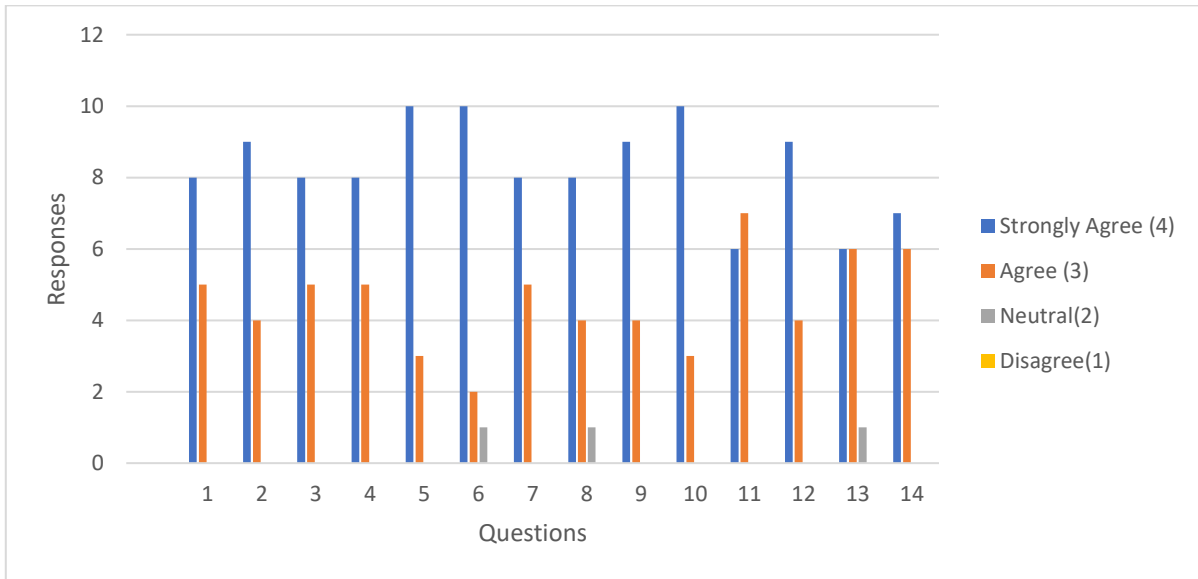

## Graph Representation for Faculty Feedback Response



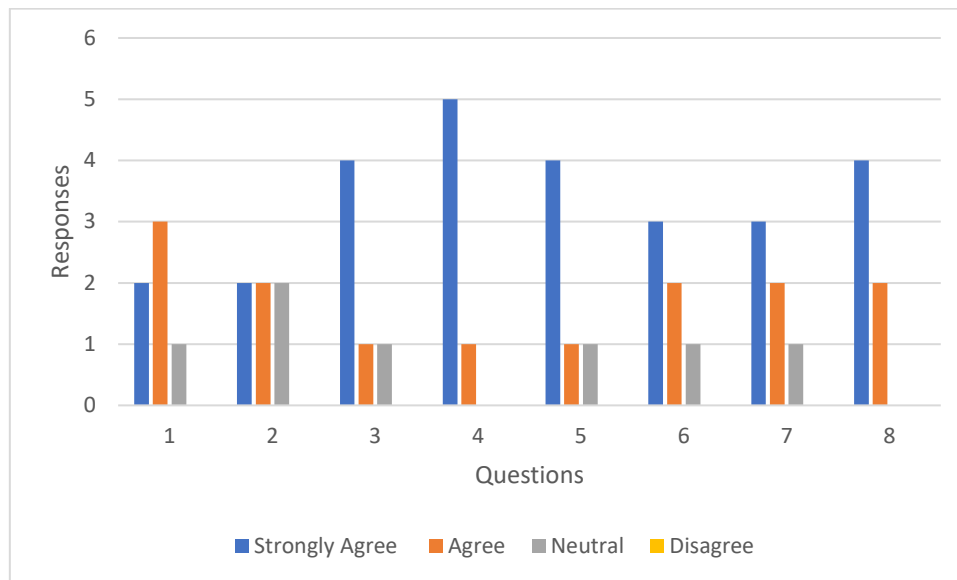
