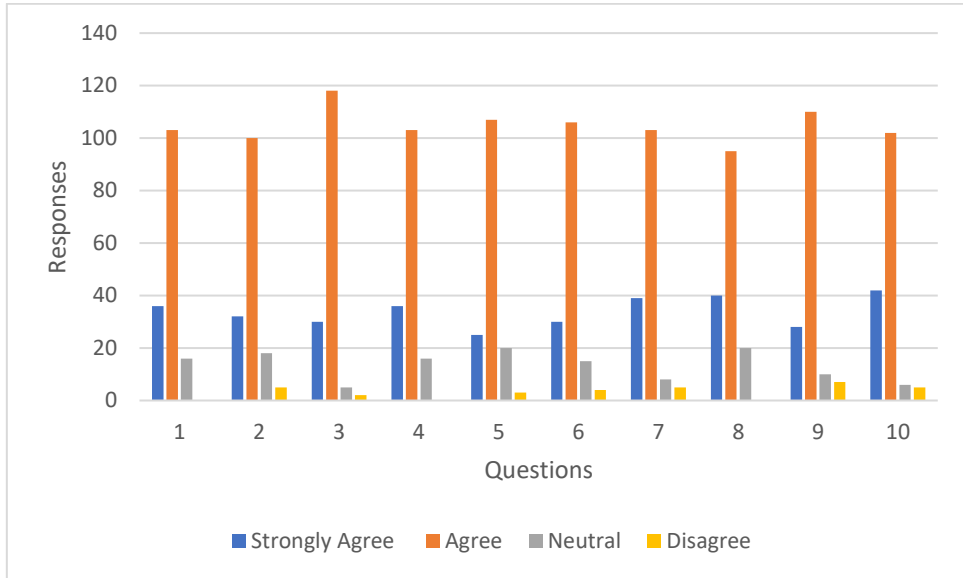

Graph Representation for Students' Feedback Response

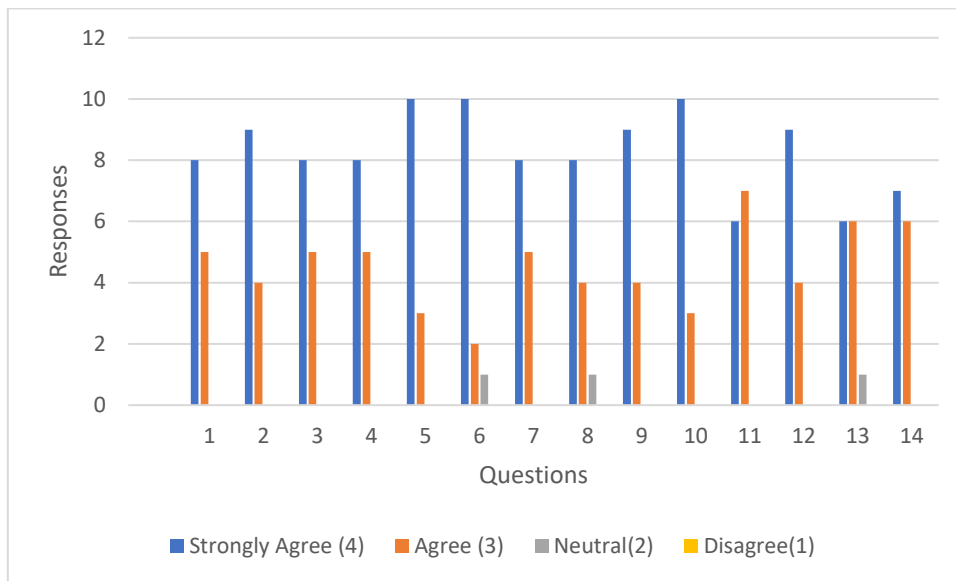

Graphical Representation of Faculty Responses



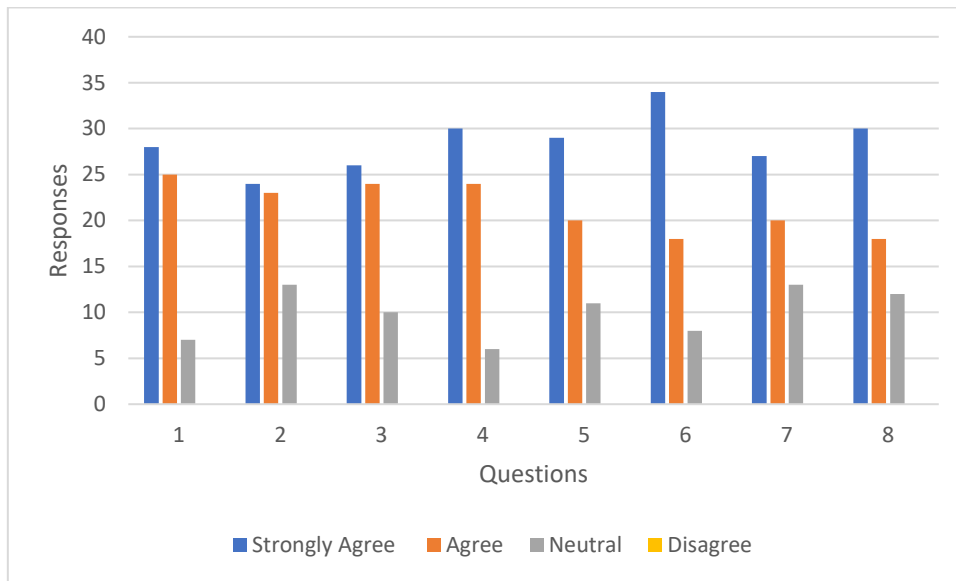

Graphical Representation of Alumni Reponses



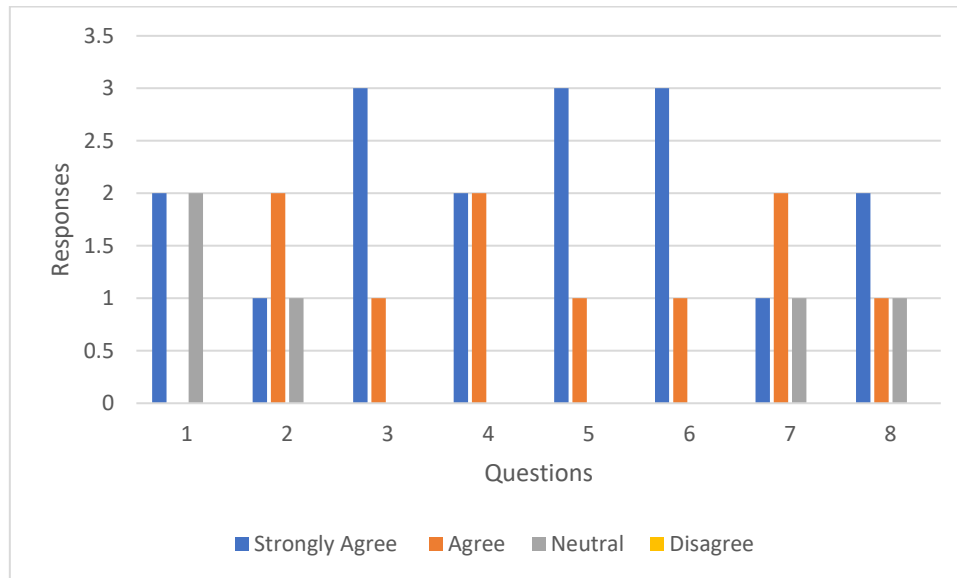
