# Anti-Ragging Policy document with zero tolerance

As the part of Educational Institution, it is our utmost responsibility to ensure a safe and conducive environment for all students. Ragging in any form is strictly prohibited within our institution. It is not just a violation of rules but also against the dignity, safety, and well-being of individuals. To enforce a zero-tolerance policy towards ragging, the following guidelines and measures will be implemented:

- Definition of Ragging: Ragging constitutes any act that involves physical or mental harassment, coercion, intimidation, bullying, or causing discomfort to any student, directly or indirectly, by any member of the college community.
- Awareness and Orientation: At the beginning of each academic year, an orientation session will be held for all students, faculty, and staff members to raise awareness about the regarded impacts of ragging. Clear guidelines regarding what constitutes ragging and ifs consequences will be provided. Important contact numbers are given to students so that they can call at any time if required.
- Formation of Anti-Ragging Committee: An Anti-Ragging Committee consisting of HoDs. Deans, faculty members, mentors and wardens will be established. This committee will be responsible for monitoring, preventing, and handling instances of ragging. Students can approach at any time.
- 4. Helpline and Reporting Mechanism: A dedicated helpline number and an online reporting mechanism is set up to allow students to report incidents of ragging anonymously. Strict confidentiality will be maintained, and appropriate action will be taken promptly upon receiving any complaint.
- Disciplinary Action: Any individual found guilty of ragging, whether actively involved or passively
  supporting it, will face severe disciplinary action. This may include suspension, expulsion, fines, or legal
  action as per the severity of the offense and as per the guidelines laid down by the Supreme Court of
  India.
- Counseling Support: Counseling and support services will be made available to both victims and perpetrators of ragging. It is essential to address the underlying issues and provide guidance to prevent further incidents and promote a healthy campus atmosphere.
- Regular Monitoring and Awareness Programs: Periodic checks and surprise with will be supposed by the Anti-Ragging Committee to ensure compliance with the policy. Additionally, workshops, seminars, and awareness programs will be organized throughout the academic year to reinforce the zero-tolerance stance on ragging.
- B. Colleboration with Law Enforcement: In cases where ragging incidents involve criminal activities, the college will cooperate fully with law enforcement authorities for necessary legal action against the perpetrators.
- Parental Involvement: Parents/guardians of students will be informed about the college's antiragging policy during admission, and their cooperation in preventing ragging will be solicited.
- Regular Review and Amendments: This policy will be reviewed periodically, and necessary
  amendments will be made to enhance its effectiveness in curbing ragging on campus.

By implementing and adhering to this policy, we aim to create an environment that fosters respect, empathy, and academic excellence while ensuring the safety and well-being of every individual associated with the institution.


