3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The programs have been granted accreditation for further 3 years. **Sri Vasavi Engineering College, Pedatadepalli, Tadepalligudem - 534 101 West Godavari Dist., Andhra Pradesh** should submit fresh online application through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Sri Vasavi Engineering College, Pedatadepalli, Tadepalligudem - 534 101 West Godavari Dist., Andhra Pradesh** as a whole.
